THE ORGANIZATION OPENED EXPRESS CARE, AN URGENT CARE CLINIC, TO PROVIDE INCREASED ACCESS TO TARGETED NEIGHBORHOODS. ADDITIONALLY, CCHC INITIATED THE DEVELOPMENT OF TWO ADDITIONAL SATELLITE CLINICS: THE CATHCART PEDIATRIC CLINIC AND THE OPHELIA GARMON-BROWN CLINIC, WHICH WILL SERVE MIGRANT FAMILIES AND AN AGING POPULATION.TO ENHANCE ITS HIV CARE AND PREVENTION SERVICES, CCHC EXPANDED ITS TEAM TO INCLUDE TWO MEDICAL PROVIDERS AND DENTAL SERVICES, LEVERAGING RYAN WHITE FUNDING TO SUPPORT THIS GROWTH.
